1. APPRECIATE REF A RUNDOWN ON ALIAS ACKERMANN VISIT.
AGREE TOTALLY WITH REF A LAST PARAGRAPH THINKING THAT ACKERMANN'S
OFFER OF BRIEFING SHOULD BE ACCEPTED WHILE ACTUAL JOINT ENGAGEMENT
PROBABLY NOT WORTHWHILE.

2. MUST NOTE THAT [] EXPERIENCE IN RECENT PAST WITH
ACKERMANN IS THAT HE IS LONG ON WORD BUT SHORT ON ACTION. TO
WIT, HE BEGAN THE JOINT OPS AGAINST THE SOVBLOC TARGET LITANY IN
MID-NOV 82 WITH AN OVERALL PROPOSAL DURING ADDO'S VISIT TO CASCOPE
HQS, PROMISING TO FOLLOW-UP ON DETAILS WITH [] NEVER HAPPENED.
DURING END JAN 83 CHIEF IC STAFF ADM. BURKHALTER VISIT TO CASCOPE
HQS, WE COINCIDENTALLY RAN INTO ACKERMANN WHO AGAIN PROMISED TO
"NEXT WEEK" GET BACK TO [] ON THE JOINT OPS BUSINESS. NEXT WE
HEARD ON THIS TOPIC WAS IN FEB 83 WHEN HQS TOLD US THEY HAD BEEN
ADVISED BY WASHINGTON CASCOPE STATION CHIEF THAT ACKERMANN WISHED
TO PAY VISIT TO HQS IN LATE FEB (LATER POSTPONED TO BEGINNING
JUNE) TO DISCUSS JOINT OPS. HQS NOTED THAT FILE INDICATED HE HAD
BEEN MAKING SUCH PLEAS ANNUALLY "FOR AT LEAST THE LAST 4 YEARS."
NOW HE HAS VISITED VIENNA AND, AS [] POINTS OUT, IS PROPOSING
YET MORE TALK IN A MONTH. WE CANNOT HELP BUT BE
SKEPTICAL OF MUCH MORE THAN CONVERSATION EVOLVING

FROM ACKERMANN. COINCIDENTALLY, IN RESPONSE TO [] REQUEST, WE
