SUBJECT: LOCAL WEST GERMAN AUTHORITIES' VIEWS ON POSSIBLE  
DISRUPTIVE ACTIVITIES BY LEFTIST GROUPS DURING VICE  
PRESIDENT'S 25 JUNE KREFELD VISIT.

1. ON 15 JUN 83, DEPUTY CHIEF, CAVIRIL'S OFFICE PASSED TO [ ] ]  
ITS VIEWS ON POSSIBLE DISRUPTION BY LEFTIST GROUPS OF VICE  
PRESIDENT'S KREFELD VISIT. TEXT FOLLOWS.

2. BEGIN CAVIRIL TEXT: 14 JUN 83 (OFFICIAL USE ONLY): FORCES  
REPRESENTING THE WHOLE SPECTRUM OF THE LEFT-EXTREMIST SCENE AS  
WELL AS MANY ELEMENTS OF THE PEACE MOVEMENT HAVE CALLED FOR  
COUNTERDEMONSTRATIONS ON THE OCCASION OF THE AMERICAN VICE  
PRESIDENT'S 25 JUN 83 VISIT TO KREFELD. THE WEST GERMAN COMMUNIST  
PARTY (DKP) AND ITS YOUTH ORGANIZATION "GERMAN SOCIALIST WORKING  
YOUTH" (SOZIALISTISCHE DEUTSCHE ARBEITERJUGEND), AS WELL AS  
PARTIES FROM THE "DOGMATIC" NEW LEFT, WILL TRY TO CONNECT THE VICE  
PRESIDENT'S VISIT WITH THE NATO DUAL DECISION AND THE STATIONING  
OF NEW MEDIUM-RANGE MISSILES IN WEST GERMANY. PLANNED DEMONSTRATIONS  
WILL PROBABLY HAVE THESE THEMES AS THEIR SUBJECT. ACCORDING TO  
RELIABLE INFORMATION, CIRCLES WITHIN THE "UNDOGMATIC" NEW LEFT  
(CIRCLES THAT MAY INCLUDE SYMPATHIZERS AND OTHERS ON THE PERIPHERY  
OF THE TERRORIST SCENE) ARE ALSO DISCUSSING PARTICIPATION IN A  
CENTRAL DEMONSTRATION IN KREFELD. THESE CIRCLES IN PARTICULAR  
MAY INITIATE LARGE-SCALE AND POSSIBLY VIOLENT ATTEMPTS TO DISRUPT  
THE VISIT. WE HAVE NO INFORMATION POINTING TO OTHER POSSIBLE,  
DECENTRALIZED ACTIONS, PARTICULARLY IN BAVARIA. END CAVIRIL TEXT.
