1. DURING 12 AUG 83 SESSION AT CASCOPE HQS, ALIAS  
ACKERMANN BRIEFLY TOUCHED ON THE DEMISE OF THE  
CASCOPE ACTIVITY WITH THE [ ] [ ] DUE TO THE  
[ ] [ ] AND STATED IN ESSENCE THAT  
REPORTED IN REF PARA 2. BECAUSE WE NEEDED OPPORTUNITY  
TO REVIEW REF, CONTENTS OF WHICH NO LONGER AT  
OUR FINGERTIPS, [ ] OFFERED NO COMMENT AS ACKERMANN  
WENT AS REPORTED BELOW EXCEPT TO SAY THAT HE WOULD  
CHECK AND GET BACK TO HIM.

2. ACKERMANN SAID THAT DEPT I CHIEF RAUSCH  
HAD DISSOLVED THE REFERAT FOR THE [ ] [ ] AND HAD  
ASSIGNED THE RESPONSIBILITY FOR THE REMNANTS  
OF THE CASCOPE CONTACT ("RESTVERBINDUNG") WITH THEM  
TO HIM. ACKERMANN SAID THEY WERE TRYING TO SIGN  
UP "ONE MAN" (PRESUMABLY [ ] [ ] AS A SOURCE AND  
HAD OFFERED TO PAY HIM. THE MAN RESPONDED THAT HE  
WAS NOT INTERESTED IN SUCH AN ARRANGEMENT BUT WISHED  
CASCOPE HELP FOR HIS ORGANIZATION (WHICH WHILE LESS  
DETAILED TRACKS WELL WITH REF PARA 2).
