1. FOLLOWING SEVERAL PRELIMINARY DISCUSSIONS BETWEEN
[] AND CASCOPE DEPT I CHIEF RAUSCH AND HIS
DEPUTY, ALIAS ACKERMANN (THE ACTUAL "TRIEBKRAFT") IT WAS
AGREED DURING A 22 OCTOBER 1983 SOCIAL EVENING THAT
THERE SHOULD BE A MEETING OF PNEXCEL AND CASCOPE
REPS ON THE SUBJECT TOPICS AT CASCOPE HQS IN THE NEAR
FUTURE. ACKERMANN SAID HE WAS TIED UP FOR THE FIRST
THREE DAYS OF THE WEEK OF 24 OCT 83 WITH A
"RESIDENTENTAGUNG" BUT THAT HE WOULD GET BACK TO []
IMMEDIATELY THEREAFTER TRUE TO HIS WORD. ACKERMANN
SENT A "SPRUCH" (ENCIPHERED) MESSAGE TO [] SUGGESTING
10 NOV 83 AS A MEETING DATE AT CASCOPE HQS AND SUGGESTING
THOSE ITEMS OUTLINED IN REF B.

2. [] HAS SUGGESTED ALTERNATIVE BALLPRK DATE
OF WEEK OF 14 NOVEMBER WHILE [] HAS SUGGESTED WE
REFINE AGENDA WITH CASCOPE BEFORE PROCEEDING TO AN
ACTUAL MEETING, WHICH WE NOW ATTEMPTING TO WORK OUT.
