1. ACTION REQUIRED: PLS CHECK WITH NVTERRACE ON STATUS OF ALIAS ACKERMANN'S VISA APPLICATION. (SEE PARA THREE.)

2. AFTER RESPONDING TO REF A REQUEST WITH REF B, WE CHECKED WITH NVTERRACE/MUNICH TO SEE IF ANY RECORD OF ALIAS ACKERMANN WAS IN THEIR FILES. WE LEARNED HE HAD APPLIED FOR A VISA AND BASED ON INS REGULATION 212 (A) (33), HE IS "CONSIDERED POSSIBLY INELIGIBLE BASED ON PREVIOUS AFFILIATION WITH NAZI PARTY." ALIAS ACKERMANN WAS REQUIRED TO COME INTO NVTERRACE/MUNICH FOR PERSONAL INTERVIEW AFTER WHICH HIS APPLICATION FOR VISA WAS FORWARDED TO NVTERRACE HQS FOR REVIEW AND AUTHORIZATION FOR ISSUE. THUS FAR, NVTERRACE/MUNICH HAS NOT RECEIVED ANY WORD FROM THEIR HQS CONCERNING THE MATTER. NVTERRACE/MUNICH OFFICER WHO WORKS IN VISA SECTION ADVISES THAT NO VISA APPLICATIONS OF THIS NATURE HAVE BEEN AUTHORIZED BY NVTERRACE HQS AND THAT THIS LACK OF RESPONSE HAS BEEN TOPIC OF DISCUSSION BETWEEN NVTERRACE/MUNICH AND NVTERRACE/HAMBURG. HIS SPECULATION IS THAT NVTERRACE HQS PREFERS NOT TO ADDRESS THE APPLICATIONS AND IS STONEWALLING THEM. ALL OF THIS DOES NOTHING TO HELP ALIAS ACKERMANN GET HIS DESIRED VISA.

3. [ ] OBTAINED ALIAS ACKERMANN'S HOME TELEPHONE NUMBER (VIA HIS VISA APPLICATION) AND CONTACTED HIM TO DISCUSS THE MATTER. ALIAS ACKERMANN WAS A GENTLEMAN AND DID NOT BLOW OFF STEAM AT [ ] BUT IT WAS APPARENT THAT HE DOES NOT LIKE THE QUESTIONING OF HIS BACKGROUND IN THE FACE OF HIS PREVIOUS POSITION AND THE FACT THAT HE PREVIOUSLY HAD U.S. VISAS. [ ] INFORMED ALIAS ACKERMANN RE REF A PROPOSAL FOR AN INVITATION TO HIM AND HIS WIFE FOR DINNER. AS EXPECTED, HE WAS FLATTERED AND PLEASED WITH THE PROSPECT AND ACCEPTED. WE ARE NOW FACED WITH QUESTION AS TO WHEN HE MAY RECEIVE HIS VISA. SINCE NVTERRACE/MUNICH SEEMS TO BE BOUND BY THE BUREAUCRATIC PROCEDURES OF NVTERRACE HQS AND IS NOT RECEIVING ANY RESPONSE CONCERNING VISA REQUESTS OF THIS NATURE, PERHAPS HQS COULD INITIATE INQUIRY ON BEHALF OF ALIAS ACKERMANN WITH NVTERRACE HQS AND GET SOMEONE THERE TO MAKE THE NECESSARY AUTHORIZATION TO ISSUE THE VISA.

4. ALIAS ACKERMANN WAS TOLD WE WOULD CHECK ON HIS APPLICATION WITH NVTERRACE AND LET HIM KNOW ITS STATUS. NO SPECIFIC FOLLOW UP DATE WAS MADE AND WE CAN HOLD OFF FOR FEW DAYS BEFORE RECONTACTING HIM. WOULD APPRECIATE ANY DETAILS HQS ABLE TO LEARN RE SITUATION PRIOR TO OUR GETTING IN TOUCH WITH ALIAS ACKERMANN AGAIN
