



- 1. By C.I.G. Directive an ad hoc committee was established to study the facilities, resources, and operations of the Strategic Services Unit, and to submit recommendations.

 Pursuant to paragraph 4-b of N.I.A. Directive No. 2, it is now necessary to initiate a broad survey of all existing facilities for the collection of foreign intelligence information by clandestine methods. This long-range project should receive high priority. The Central Planning Staff does not yet have sufficient personnel to conduct the survey, but the necessary personnel were included in the personnel requisition for the Central Planning Staff submitted to the four permanent members of the Intelligence Advisory Beard on 26 February.
- 2. A directive making necessary provisions for the survey should be published without delay. Conduct of the survey should begin as soon as sufficient personnel are provided.
- 3. The proper Intelligence Advisory Board for this survey includes the Director of the Federal Bureau of Investigation, who has been invited to sit as a member and has accepted, in addition to the permanent members.
- 4. Paragraph 3 of N.I.A. Directive No. 1 provides a procedure by which the necessary directive can be published and carried

cut by unanimous approval of the Director of Contral Intelligence and the Intelligence Advisory Board, without action by the National Intelligence Authority.

It is recommended that the enclosed directive be approved, and that each member of the Intelligence Advisory Board arrange for necessary implementation by his agency.

MEMORANDUM FOR

SUBJECT: Survey of Facilities for Collecting Foreign Intelligence
Information by Clandestine Methods

I have read your memorandum of 1 March 1946 to Admiral Souers on the above subject. Several suggestions come to mind:

- 1. That the directive be delayed until report of the ad hoc committee studying SSU is received. It is possible that recommendations might be made to set up an agency to perform many of the functions covered by your suggested directive. We would thus be in a position to define the scope of objectives of the study more accurately.
- 2. If the report of the ad hoc committee on SSU recommends the establishment of a separate agency under the direction of CIG, the projected study might well be in the nature of a directive to the agency and provide for the coordination of amalgamation of the services now performed by other agencies engaged in related operations.
- 3. I have been informed by my former officers of OSS that studies have been made by them outlining the projected functions for peacetime operations of such an organization, and these should be available in the OSS files.
- 4. When the study is made, I would suggest that some of the following former officials of OSS who have had positions of responsibility in that organization and who have prepared, or collaborated in the preparation of the studies for peacetime SIS programs might well be called to advise the committee. They are:

Mr. Frank Wisner, of Carter, Ledyard & Milburn, MYC Colonel William Jackson, of the same firm

Mr. David Bruce, Washington, D. C.

Mr. Baxter, President of Williams College, who headed SIS operations during the war

Dr. William Langer, Harvard University

Dr. Robert Blum, associated with J. H. Whitney, in Radio City, NYC


