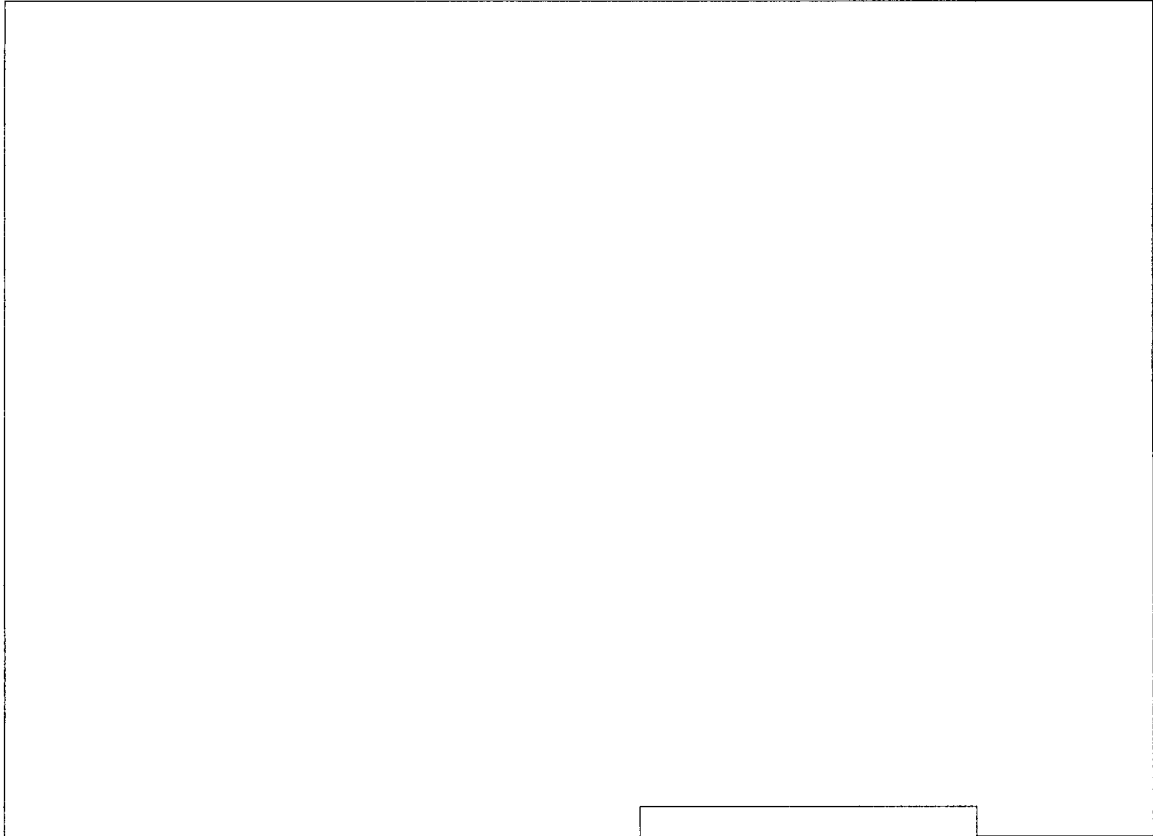

Col. Shannon reference enabling legislation. Arrangements are being made for the Director to see Mr. Schaub of Budget Bureau, prior to submission of legislation to Mr. Webb, Director.

[redacted] ORE, reference proposed Program of Cooperation between RDB and CIA; will submit ORE comments.

Mr. Doherty, [redacted] reference information that Satellite countries' representatives to US were being recalled (See Memo). Deputy Director arranged to have information delivered to Secretary of Defense, Secretary of State, Captain Grantham for Admiral Leahy; and for inclusion in Daily Summary of today. \*Attached.

[redacted] and Col. Shannon reference necessity for travel orders for Mr. Cassady from time to time; has been cleared with the Director.
