A LARGE ZONE IN PINAR DEL RIO PROVINCE WITHIN A PERIMETER BOUNDED BY THE CITIES OF SAN CRISTOBAL, SAN DIEGO (DE LOS BANOS), CONSOLACION DEL NORTE, AND LAS POZAS IS HEAVILY GUARDED BY SOVIETS WITH THE ASSISTANCE OF PERUVIAN AND COLOMBIAN NATIONALS. (HEADQUARTERS COMMENT: IT IS DOUBTFUL THAT GROUND FORCES COULD EFFECTIVELY CONTROL AS ONE COMPLETE AREA A ZONE AS LARGE AS THE ONE CITED ABOVE. THE GRIDS FOR THE ABOVE AREAS ARE AS FOLLOWS:
