THIS TELEX IS TO CONFIRM THE ORAL UNDERSTANDING OF JULY 21, 1975 BETWEEN OUR COMPANIES THAT THE EXPIRATION DATE OF THE ESCROW AGREEMENT IS EXTENDED FROM JULY 31, 1975 TO SEPTEMBER 1, 1975 AND THAT ALL OTHER TERMS AND CONDITIONS OF THE ESCROW AGREEMENT REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.

IN ADDITION, THE FOURTH SENTENCE FROM THE TOP OF THE FIRST PARAGRAPH OF THE LETTER AGREEMENT DATED JANUARY 17, 1975 IS AMENDED TO READ AS FOLLOWS:

"IT IS AGREED THAT UPON CONFIRMATION BY BUYER AND SELLER JOINTLY OF COMPLIANCE WITH THE TERMS OF SAID AGREEMENT, THE ESCROWED FUNDS SHALL BE RELEASED TO AIR AMERICA ON OR BEFORE SEPTEMBER 1, 1975, AND IN THE EVENT THAT NO NOTICE OF CLAIM UNDER THE AGREEMENT HAS BEEN GIVEN TO THE ESCROW AGENT BY SEPTEMBER 1, 1975, THE ESCROWED FUNDS SHALL BE RELEASED TO AIR AMERICA ON THAT DATE"

ALL OTHER TERMS AND CONDITIONS OF THE LETTER AGREEMENT REMAIN IN FULL FORCE AND EFFECT.
