

USAID/WASHINGTON, WHICH HAS PROVIDED JOINT SERVICES з. CONTRACT FOR MISSIONS, HAD PREVIOUSLY TAKEN POSITION THAT FOLLOW-ON AIR SERVICES COULD ONLY BE CONTRACTED FOR BY U.S. CARRIER AFTER SUCCESSFUL BIDDING. HOWEVER, ON RECEIPT OF GVN NOTE, USAID/WASH-INGTON FIXED ON POSITION THAT IT WOULD CONTRACT ONLY WITH AVN AND PAYMENT WOULD BE IN PIASTERS DERIVED FROM A FORM OF COUNTER-PART TRUST FUND GENERATED FROM THE SALE OF ITEMS BROUGHT INTO SVN UNDER THE COMMODITY IMPORT PROGRAM. ONLY USAID, AMEMBASSY AND SAAFO FLIGHTS COULD BE PAID FOR UNDER TERMS OF THIS TRUST FUND: STATION AND DAO WOULD HAVE TO ARRANGE THEIR OWN PIASTER PAYMENTS.
