4. FURTHER, FOR SMITH, THERE MUST BE "A CLEAR PLAN BEHIND ME AS TO WHERE WE'RE GOING." THERE MUST BE "A BIGGER AIM THAN FOUR WEAPONS GETTING BACK INTO COLLECTION POINTS."
