WAS MEMBER OF BANDERISTS AND WAS TRAINED BY SMOTH AS W/T OPERATOR. FOR HEALTH REASONS WAS NEVER USED OPERATIONALLY BUT WAS EMPLOYED FOR SOME TIME AS PART OF OPS STAFF AND WHEN SMOTH CONTACT WITH BANDERISTS WAS BROKEN, SMOTH RESETTLED HIM IN U.K.

B. AECASSOWARY 29: MAN BY THIS NAME WAS POLITICAL WORKER
