Her date of birth is recorded as January 1920 and her address is given as 9 Shaws Cottage, Perry Rise, Forrest Hill, S.E. 23, London. Her last employment before leaving Canada was as a clerk with the Canada Life Assurance Company in Toronto, Ontario. <b>SMABLE</b> files reflect no detrimental information on Miss <b>HOOPER</b> and persons interviewed concerning her have likewise reported nothing derogatory.</p> <p>2.
