Excerpt from State Daily Log - September 1966:

22 September

Threat on Lives of DOBRYNIN and FEDORENKO

Sid Telford delivered a copy of a memorandum of conversation dated 21 September 1966 wherein a Soviet Embassy official furnished nonspecific information about a plan of a Ukranian Nationalist Group to kill DOBRYNIN and FEDORENKO in the U.S. The assassin's name is SIKORA and he presently is in the U.S. The same information was passed to INS, FBI, New York Police, and the Washington Metropolitan Police. Mr. Telford asked for any information we might have to help identify SIKORA. They already have info that the "Benderovski" is an organization set up by the followers of Stephen Bandera who was assassinated several years ago, allegedly on Soviet orders. The main problem is how to identify SIKORA in the absence of any additional info. Sec. Rusk is personally interested in this case and arranged through State Security in New York for the New York NYPD to put a discreet protective watch on DOBRYNIN, FEDORENKO, and GROMYKO. The Washington Metropolitan Police will do the same if and when these Soviet officers come to Washington. Mr. Telford later asked for a trace on Rev. Vasil Waruariv and Mr. & Mrs. Waruariv who reside at 6703 6th St., N. W., Washington, D.C., the address of the Association of the Ukranian American students. He also asked for a trace on Jaroslaw Stetzko an official of the anti-Bolshevik Bloc of Nations. I suggested to Mr. Telford that State go back to the Soviets and ask for any details they may have on the alleged plan that would be an assistance in identifying the person using the name SIKORA. This is a very common name and without more details an identification is not likely. This is separate from the problem as to whether or not it is the man's true name.
