I, Ludwig Albert, do hereby acknowledge that I have this date received the sum of DM 5,523.00 (five thousand, five hundred, twenty-three Deutsche Marks) from the Government of the United States of America. In accordance with the agreement under which these funds were entrusted to me, I have purchased with these funds on behalf of the United States Government one Volkswagen Export, motor number 1-0431-258, license number AH 85-4809.

In consideration for the delivery of these funds to me and for the granting of this vehicle into my custody and in consideration for such other benefits as I have received or shall receive from the Government of the United States, its Agencies or representatives, I do hereby agree as follows.

It is understood and agreed that this vehicle, although officially registered in my name, is now and will remain the sole property of the United States Government; and that it is to be held by me subject to the direction of the United States Government or its authorized representatives and that I have no personal proprietary interest in or claim upon this vehicle; and that in the event of my death or disappearance, or at such other time as the United States Government or its authorized representatives shall designate at its discretion, this vehicle shall be returned into the possession of the United States Government, and that neither I, nor my estate, nor my heirs, shall have any claim upon it.

It is further understood and agreed that this vehicle may not be sold, pledged, or otherwise obligated by me or my representatives or agents for any reason whatsoever, without specific authorization in writing from the United States Government or its authorized representatives.

It is further understood and agreed that this contract shall not be construed to grant to me, or my agents or representatives any rights or privileges not

specifically stated herein; and that I shall be personally responsible and liable to the United States Government for the proper custody of this vehicle.

It is understood and agreed that in addition to this acknowledgement, direct to the United States Government, for receipt of these funds I will also be required to affix my signature to a duplicate receipt (for these same funds) in which the firm Siegert & Co. G.m.b.H., acting on behalf of the United States Government, appears as the source of these funds. In signing this duplicate receipt with Siegert & Co. G.m.b.H., I fully understand that the purpose of this duplicate receipt is to be used only, if so directed by the United States Government and/or its authorized representatives, in the event of legal action arising out of my possession and/or disposition of these funds.

wird folgender Treuhandvertrag geschlossen:

Der Treugeber stellt dem Treuhänder ein Personenkraftwagen  
Type Volkswagen-Export Fahrgestellnr. 1-O 356 178  
Motornr. 1-O 431 258 für die ihm übertragenen Aufträge  
zur Verfügung.

2. Der Treuhänder verpflichtet sich, für den genannten Pkw die polizeiliche  
Zulassung auf seinen Namen zu bewirken.

3. Der Treuhänder verpflichtet sich, ohne Wissen und ohne schriftliche  
Genehmigung des Treugebers über den genannten Kraftwagen in keiner  
Weise zu verfügen, vor allem ihn nicht zu veräußern, zu verpfänden  
oder zur Sicherung abzutreten und etwaige Pfändungen sofort dem Treu-  
geber anzuzeigen, ausserdem dazu, das Wagen pfleglich und schonend  
zu behandeln und alle Unfälle dem Treugeber sofort mitzuteilen.

4. Der Treugeber verpflichtet sich, die Kosten der Haftpflichtversicherung  
und Teilkaskoversicherung sowie die Kfz-Steuer für den genannten Pkw  
zu übernehmen und dem Treuhänder die hierfür aufgerundeten Beträge zu er-  
statten.

5. Der Treuhänder verpflichtet sich, Versicherungsfälle umgehend dem Treu-  
geber mitzuteilen und sich den Weisungen des Treugebers hinsichtlich  
Pflage, Behandlung, Reparaturen u.ä. des Kfz. zu fügen.

6. Der Treugeber verpflichtet sich, zur Deckung der Betriebskosten  
DM 0.18 pro Kilometer zu erstatten für alle Geschäftsfahrten. Diese  
sind im Fahrtenbuch ausreichend nachzuweisen. Privatfahrten des Treu-  
händers werden nicht vergütet.

7. Der Treuhänder verpflichtet sich, den Pkw monatlich nicht mit mehr als  
10% der Fahrstrecke (in km) für private Zwecke zu benutzen.

8. Der Treugeber ist berechtigt, das Treuhandverhältnis jederzeit grund-  
und fristlos zu kündigen.
