ON 10 JAN CURR TELEGRAM FWD TO SUBJ IN ATTEMPT TO CANCEL PEANNED MEETING IN VIENNA BECAUSE OF LACK OF FUNDS; HOWEVER SUBJ HAD ALREADY DEPARTED SLAZBURG FOR VIENNA BY TIME MSG ARRIVED AT HIS HOME. SUBJ ARRIVED AT APT PLACE AT PROPER TIME IN VIENNA FOR ABOVE MENTIONED MEETING. HOWEVER BECAUSE OF PREV ARRANGEMENTS WITH SUB SOURCE OF BULGARIAN NET AND YUGOSLAV NET HE WENT TO SEE FRIEND OF HIS, DR BAROSCY (PHON) LAWYER IN VIENNA, FROM WHOM SUBJ REC LOAN OF ANS 7000. SUBJ STATED TO BAROSCY THAT HE WOULD SEND MONEY BY MAIL OR BRING IT IN PERS ON OR BEFORE 17 JAN CURR. PRIOR TO SUBJ ASSOCIATION WITH THIS RGN HE WAS ATTEMPTING TO ESTABLISH IMPORT EXPORT BUSINESS INVOLVING AM LUBRICANTS WHICH HE HAD REGISTERED WITH AUSTRIAN GOVT AND MADE THE LOAN IN CONNECTION WITH THIS ALLEGED BUSINESS.
