SUBJECT: ALLEGED VIDELA LETTER TO PRESIDENT CARTER

1. ACCORDING TO SOURCES IN THE POPULAR CONSERVATIVE PARTY, PARTY MEMBER JUAN ESPIL, WHO IS A NEPHEW OF ARGENTINE AMBASSADOR TO US AJA ESPIL AND ALSO A CONFIDANT OF PRESIDENT VIDELA, VIDELA IS UPSET OVER AJA ESPIL'S RECENT PUBLIC STATEMENTS IN THE US BLAMING CERTAIN UNIDENTIFIED SECTORS OF THE STATE DEPARTMENT FOR US HUMAN RIGHTS POLICIES VIS-A-VIS ARGENTINA. ACCORDING TO THESE POLITICAL SOURCES, VIDELA DID NOT AUTHORIZE AJA ESPIL TO TAKE THIS INITIATIVE AND FOREIGN MINISTER MONTES HAS ANSWERED A PRESIDENTIAL INQUIRY STATING THAT THE AMBASSADOR'S ACTION WAS NOT THE RESULT OF ANY INSTRUCTION FROM THE FOREIGN MINISTRY EITHER.
