ANSWER: MAITRE JACQUES VERGES, THE FRENCH ATTORNEY WHO HAS ACHIEVED NOTORIETY FOR HIS LEGAL DEFENSE OF

THE INDEFENSIBLE. PRESIDENT OUSMANE'S CDS PARTY-

DEFEATED IN THE JANUARY 12 LEGISLATIVE ELECTIONS--HAS HIRED MAITRE VERGES TO MAKE ANOTHER LEGAL RUN AT OVERTURNING THE ELECTION RESULTS.

3. NIGERIENS HAVE REACTED WITH INDIGNATION TO MAITRE VERGES' WELL PUBLICIZED APPEARANCE IN NIAMEY OVER THE WEEKEND OF FEBRUARY 10-12 TO PRESENT HIS BRIEF TO THE SUPREME COURT. THE DECISION TO BRING IN A HIRED GUN FROM FRANCE--ESPECIALLY ONE AS NOTORIOUS AS VERGES--HAS PROVOKED A NATIONALIST RESPONSE FROM THE MAN IN THE STREET. MOST EDUCATED NIGERIENS DO NOT TAKE WELL TO THE PERCEPTIONS--REAL OR IMAGINED--OF INTERFERENCE BY THE FORMER COLONIAL POWER NOR DO THEY THINK VERY HIGHLY OF THOSE NIGERIENS WHO TEND TURN TO FRANCE FOR ANSWERS.

4. AGGRAVATING THIS ANTI-COLONIALIST REACTION AGAINST VERGES IS THE FACT THAT THE SUPREME COURT HAS ALREADY RULED ON THE PRINCIPAL LEGAL ISSUE: THE VALIDITY OF THE EIGHT SEATS IN THE NATIONAL ASSEMBLY SEATS ALLOCATED TO SPECIAL ELECTORAL DISTRICTS (REFTEL). MAITRE VERGES' INVOLVEMENT IN A CASE ALREADY LOST BY NIGERIEN ATTORNEYS IS PERCEIVED AS A POLITICAL PLOY AIMED AT INTIMIDATING THE COURT. IN FACT, VERGES' PUBLIC STATEMENTS SUGGEST THAT HIS BRIEF DIFFERS LITTLE FROM THE EARLIER MOTIONS SUBMITTED BY THE CDS AND REJECTED BY THE COURT. THE PRINCIPAL DIFFERENCE APPEARS TO BE VERGES' ARGUMENT THAT THE PROPORTIONAL REPRESENTATION SYSTEM APPLIED TO THE OTHER ASSEMBLY SEATS SNOULD ALSO HAVE BEEN APPLIED TO THE SPECIAL DISTRICTS. IN THE EIGHT SPECIAL DISTRICTS--CREATED TO ENSURE NIGER'S SMALLER ETHNIC MINORITIES WOULD BE RESPRESENTED--THE SEAT GOES TO WHICHEVER CANDIDATE WINS A PLURALITY.

5. COMMENT: PRESIDENT OUSMANE--BY NIS APPARENT UNWILLINGNESS TO ACCEPT TNE VERDICT OF THE COURTS ON THE LEGALITY OF THE ELECTIONS AND HIS OBSTINANT INSISTENCE ON HIS CONSTITUTIONAL RIGHT TO REJECT THE OPPOSITION MAJORITY'S CANDIDATE FOR PRIME MINISTER--IS RUNNING REAL POLITICAL RISKS. PRESIDENT OUSMANE'S INTENT MAY BE TO PORTRAY HIMSELF AND NIS COALITION AS THE DEFENDERS OF THE RULE OF LAW AND CONSTITUTIONAL DEMOCRACY. BUT NIGERIENS INCREASINGLY ARE FRUSTRATED BY THE POLITICAL MACHINATIONS AND THE CONSEQUENT LACK OF PROGRESS TOWARDS FORMING A NEW GOVERNMENT. END COMMENT. DAVISON
