1. Western Germany. Frankfurt and Bonn. [] *4 Dec 1950*
2. This project is closely related to BOB's Camlet operation and Camlet is aware of Camise's close connection with us. Details of the Camise operation may be found in MGFA-3877.
3. a. Western German Federal Government. Political targets of opportunity.
b. SPD parliamentary representation, SPD Party Executive, various key government officials.
c. Agent briefed to pay particular attention to extreme rightist and leftist *Bird-dog and cut-out.*
elements; acts as
4. a. Camise
b. Full personal data on Camise is available in Washington. The appropriate references are not known in FOB.
5. a. Camise has natural cover as a well-known reporter of a large German newspaper.
b. Camise knows that she is in contact with the representative of a high-level American intelligence agency.
6. Contacts, pre-arranged by telephone, take place at case officer's or agent's house.
7. We have considerable control over Camise. She is working under an assumed name, she obtained her present position only through our influence, and knowledge of her wartime activities gives us a hold on her, too. Actually, however, we are fully satisfied that Camise works for us

primarily because of ideological considerations. Camise is emotionally a very unstable person and the possibility always exists that she might come under the influence of a man who would be able to undo whatever loyalty she has to us at present. The hold of false identity and war-time record will decrease as German national feeling increases and this control factor can be considered nil probably within a year.

8. None necessary.
9. This project has to be coordinated with Berlin's Camlet operation.
10. Camise has been in contact with this agency's representatives (prior to 1946 with those of OSS and SSU) since 1945. Exact date not known to FOB. Project will continue indefinitely.
