at Göttingen under (Professor) PRANDTL, where he studied aerodynamics with particular emphasis on supersonic speeds through the use of wind tunnels obtained through the vacuum of a concrete bunker. Professor PRANDTL had two particularly significant assistants, (Professor KANNELIANN and (Professor AKERITH (sic). Professor KANNELIANN is now believed to be in the United States as is Professor PRANDTL. Professor AKERITH, successor to PRANDTL, is now believed to be in Zurich according to Professor TANK. REIFFER was most active as a liaison man between scientific circles and the Ic/Luft and later the Special Staff of the SD, which was led by HINDILER's brother as a weapons testing institution for the SS.

REIFFER is the brother-in-law of the well-known STAML-FISCHER in Basel, witzerland a former British informant. REIFFER is presently living in Switzerland with his wife and is in contact with Professor ITSCHER (sic).

- b) (Professor ITSCHEER: This professor is the son of a well-known historian in Switzerland by the same name, who harbored LENIN during the latter's exile. When LENIN returned to Russia, Professor ITSCHNER accompanied him there where he became a leader of the Folitical Academy and an official of the Politbure. This Professor ITSCHMER is allegedly accredited with having accomplished the background negotiation for the understanding between STALIN and HITLER, and he remains today a trusted follower of STALIN.
- c) (Major/INRENOW: This person is a former member of the Czarist Secret Service and allegedly maintains secret contacts inside Moscow and is believed at present to be in Turkey.
- 3. In view of the above conflicting details and lack of clarification, this was inclined to discredit ROHTLA's statements. However, to take advantage of his offer to be of service to the United States in establing contact with above alleged persons, this is prepared a questionnaire for is to give ROHTLA to complete on the basis that no consideration could be given to his proposal without full knowledge of his personal background. Accordingly, ROHTLA provided the following personal, biographic data, which he insisted was absolutely reliable.

Jan ROHTLA: At the end of the war he went to Sweden, where he changed his name to ROHTLA in order to evade being handed over to the Soviet.

Personal and Military History: 1934: Upon completion of secondary school in Germany he was sent as a Hitler Youth leader to visit Argentina.

1935: Worked in Hamburg and Berlin as a member of the NSDAP in charge of the organization of the NS-WELFARE OF GERMANS RESIDENT ABROAD THROUGHOUT THE WORLD.

1936: Fritored military police training in Gormany.

1937: Entered GEHEILE STANTSPOLIZEIAMT (Gestape) and was on the staff S88 of the Air Force and the OKW.

1938: Was assigned to Ic/Ao of the Condor Logion in Spain.

1939: Returned to Germany from Spain after being wounded and was transferred to OBERSTLEUTNANT FLEISCHHAUER

1940: Employed by the organization of (REICHSLEITER) ROSENBERG in the WORLD SERVICE.

1941: Wounded in combat and ordered to Ic/Luft of the OKW on a special mission in Spain.

1942: Bocame personal assistant to Gauleiter

Reichsstatthalter/SPRENGER, where he remained in charge of coordination between Party, State and Wehrmacht until the collapse of the Third Reich.

1946: At the time of the surrender he was in Denmark, where he made his way to Sweden, joining a group of Estonian refugees there under the name of ROHTLA. On June 8, 1946 with a group of Estonian refugees in Sweden, he crossed the Atlantic Ocean in a small, 11 meter boat and landed in Buenos Aires, Argentina on 9 September 1946, where the Argentine Government in recognition of the perilous flight of these refugees issued all of them permits of residence and identity papers. Thus, he has been forced to use the name ROHTLA as his only documentation is in this name.

1947: He organized the AYUDA SOCIAL MADRES Y NINOS ALEMANOS in Buenos Aires. Later he organized a travel bureau AGILE in Buenos Aires together with a (Major) Paul/ELLOR, a retired former employee of the British Embassy.

1948: Came to Chile, where he has been engaged in a fishing business at Concon and Quintero.

This identity card is still valid, and on the basis of these two documents in 1950 in lieu of a passport a re-entry permit was issued in Mondoza, Argentina. The identity paper was stamped with a Chilean visa which has since expired.

Religion:

Was baptized and confirmed as an Evangelist.

Political Affiliations:

Although a momber of the NSDAP, he claims he was never a thorough believer in Hitlerian and that he has dedicated himself to exposing and branding the errors of post-war Hitlerism. Ho claims to be a violent enemy of Communism . and is not a member of any political party at the present time.

Travel

Aside from the above mentioned travel, he lectured against Soviet imperialism at the May Day celebration in 1941 at Wiel, Rorschach and St. Gallen, Switzerland.

Educations

Four years preliminary school, 9 years of reform, Real Gymnasium. Secondary School at Rathemaun at the HINDENBURG SCHOOL in Senftonberg, Nieder-Lausitz.

Language

Fluont German, French and Spanish; fair Latin English and Swedish.

Military Decorations:

Medalla de la Campaña de España; Spanish Cross; Merit Medals, first and second class; and the Gold Hitler Youth Emblem.

Writings and/or Publioations:

In Gormany he wrote indoctrination articles on the theme of the Struggle of Destiny Against Red Imperialism. He continued writing for the press in Argentina, where his articles appeared in the German language daily "FREIE PRESSE". In Chile he has prepared 600 pages of the manuscript for his

book "DIE IRRLICHTER", which concerns itself with the psychological aspects of the struggle against Red imperialism.

Persons Living at Same Address and/or Close Associates: He resides in the house of Maria MORGADO de SCHERF, Avenida Borgoña 23623, Concon: where also resides an Italian by name of Franco HNIVOLARI.

He claims that he has never been arrested nor convicted in any court and that no one in Gormany is aware of his present identity or whereabouts.

Comments on Intelligence
Experience:

Subject claims that his intelligence experience with the Germans consisted of a special police training in criminal and state police groups in the region of Erfurt and later in the office of the State Police in Berlin. Later under orders of Dr. BEST in Department 3, he was attached to OKW in Spain, where he was a close friend of a chief of a special staff of General France, Willie KHUN, and the chief of the SIPM, Col. AUNDRIA. (Field Note: Remaining details have not been translated to date by FUGIENT but will be forwarded under separate cover if considered significant.)

4. The above personal data on the source of the enclosure to TCS-1124 are forwarded at this time in order to aid Headquarters in the evaluation of latter information. It stated that although FISCHER (ROHTLA) is a former Gestapo agent, he is a bitter enemy of Communism and that he sincerely desires to cooperate in any way possible with the United States against Communism and the revival of any resemblance to the HITLER, NATIONAL SOCIALIST PARTY OF GERMANY.

was in contact with an intermediary of Martin RORMANN's. When queried further on this the latter told _ _ _ that his contact was with a Gauleiter. Willio XSTUIR, who was in contact with BORMANN, and he claims that ne would be able to obtain BORMANN's whereabouts but that it was a matter of great concorn to him as to whother this should be disclosed. He stated that STOHR was an extremely intimate friend of his and that he wos: -- the chief of the information department under BORMANN and liaison man with Dr. GOEBBELS. STUHR became the successor to Gauleiter BURKELY as Gauleiter and Reichstatthalter of West Mark, where he distinguished himself by his intelligent procedures during the evacuation of Lorraine and Saarpfalz. A literal translation of FISCHER's (ROHTLA's) report to I contained the following statement: "The American must also bear it on his conscience and promise it on his word of honor that he does not deliver us to a justice of vengeance, but consider the contact to STOHR as a secret tie of a common cause in the struggle against the Red imperialists." Neither — — nor — — — were able to determine exactly what FISCHER (ROHTLA) meant by this statement, unless he was apprehensive over the possibility that he and STUHR might be turned over for punitive action in view of their Gestapo record. This [___] has no knowledge of Will's STUHR and is inclined to question the soundness of FISCHER (ROHTLA). Therefore, any enlightenment which Headquarters might provide on the foregoing would be greatly appreciated by this - 14
