1. After several months of association with [REDACTED] and [REDACTED], several things have come into our discussions which should be summarized. Also the work being done by [REDACTED] and [REDACTED] has reached a point where some definite determinations will have to be made regarding future aspects.

2. Foremost in [REDACTED] mind is his ability to maintain an adequate supply of LSD-25. For the moment [REDACTED] has a very close relationship with [REDACTED] representative. Continuing supplies of LSD-25 are assured but are commensurate with the amount of research results turned over to [REDACTED]. [REDACTED] feels we should be investigating the possibility of producing LSD-25 synthetically if we are going to be using large amounts of the material over an extended period. He would like to discuss this problem with the [REDACTED] What is your reaction to this?

- a. Electroencephalographic studies are not being made under [REDACTED] program just yet. [REDACTED] coast representative volunteers to [REDACTED] b. These studies are in the process of being completed by another researcher. [REDACTED] will get a copy of the results and will give to us for permanent retention. If necessary [REDACTED] will expand on these studies to whatever extent we direct.
 - b. Metabolic tests are not being attempted now -- qualified personnel are not currently available and [REDACTED] does not want to start this specialized work until toxicological tests in progress are completed. Efforts to find an antidote will also be guided by toxicological test results.
 - c. Tests with monkeys for last conditioning and effects of in intoxication present numerous problems:

(1) We can only approximate cost which is itemized below:

(a) 10 monkeys @ \$70 each	\$ 700.00
(b) Board and room @ \$5 per week per monkey for a minimum of 16 weeks	800.00
(c) Miscellaneous expense for immunizations and reserve fund for monkey casualties	200.00

(d) Personnel to take care of facilities and controlled administration of LSD-25 on a seven-day week basis. There is \$35 per month for four months	\$1,620.00
(e) Technician for four months - \$400.00	<u>\$400.00</u>
Total -	\$4,920.00

(2) These figures are predicated on the loss of [REDACTED] If he were to be assigned to [REDACTED] for research on LSD-25 the figure would support the activity for one year and completely cover requirements listed thus far.

(3) Work with monkeys will naturally take a large supply of LSD-25 so we must think of some way to keep the supply coming from [REDACTED] or develop another source of material.

Incidentally, the [REDACTED] people volunteer that they are doing a survey of the published literature and when completed will give [REDACTED] copy of their findings. It will be interesting to see how this bibliography compares with what we have.
