1. [] ADAMANT IN DESIRE ATTEND 17 NOV MEETING. THIS PARTIALLY DUE FACT FUELLBORN'S EAST BERLIN LAWYER RECEIVED NOTIFICATION O/A 10 NOV THAT HE WOULD NOT BE ADMITTED TO TRIAL ON 12 AND 13 NOV.

[] THUS CONVINCED TRIAL REALLY HELD AND IS DETERMINED MEET SSD CASE OFFICER ONCE AGAIN IN ORDER LEARN [] DISPOSITION IF POSSIBLE.

ALSO WISH POINT OUT THAT UNDERSTANDING WITH [] SINCE DEFINITE DATE FOR TRIAL WAS SET HAS BEEN PLAY ALONG UNTIL TRIAL HELD THEN GIVE UP ALL ATTEMPTS DEAL WITH SSD IN EVENT NO NEW HOPE.

2. SINCE NO PRACTICAL WAY STOPPING HER AND IN VIEW NEED FOR GOOD RELATIONS WHEN HANDLING RESETTLEMENT ISSUE, FEEL BEST MOVE IS TO CARRY CASE THROUGH THIS MEETING THEN MAKE DEFINITE TERMINATION. ADMITTED POSSIBILITY THAT [] WILL NOT RETURN AFTER 17 NOV BUT CONVINCED THIS SMALLER RISK THAN ANTAGONIZING HER BY PHYSICAL DETENTION. BELIEVE [] CAN BE CONVINCED ABANDON CASE AFTER THIS MEETING: FEEL SHE ALSO WEAKENING IN FAVOR RESETTLING IN FEDREP.
