[] interviewed William Darden, Staff Director of the Senate Armed Forces Committee in the Helms period. This interview was not particularly informative. He has received no word yet from Legislative Liaison on his request for an interview with Senator Stennis.

We received a call on 27 October from [] Legislative Liaison, about drafting a speech for Mr. Casey to deliver before the Goldwater Committee on 3 November in support of a resolution to establish a National Intelligence Museum.
