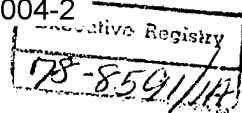

Dear Mr. Baratz:

I appreciate your prompt response to my verbal undertaking to participate in the panel discussion on the intelligence agencies and the academic community in New Haven on 10 June 1978. Thank you for the invitation to lunch with Professor Peter Steiner, which I am pleased to accept, though with the following proviso.

In my reply to the informal invitation from your office I said that there was a roughly twenty percent chance that I might not be able to meet the engagement. I have also ascertained that Mr. Anthony Lapham, our General Counsel, who was designated by Mr. Knight of your office as the replacement you would prefer, will be unable to serve. I regret having to say so, but I really do believe that if I should not be available at the time it is better that the Intelligence Community not be represented on your panel. Having been concerned with the scheduling of such events myself, I appreciate the awkward position this leaves you in. I am afraid, however, that I cannot improve upon it. Perhaps it would be better for you to withdraw the invitation to me and resign yourself to an all-academic discussion [redacted]

[redacted] If that should be your choice I shall understand and remain grateful to you for the invitation.

1. Action Requested: Approval of attached reply to Baratz and advice on a possible replacement if you are unable to participate in the 10 June panel discussion.

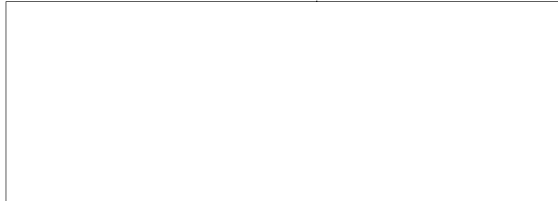
2. Background: The letter from Baratz was in response to the verbal reply to the AAUP informal invitation (your comment on the Routing and Record Sheet of my memo of 2 March, which is attached), which I passed to Jonathan Knight of the AAUP staff. Knight's response, and now the Baratz letter, have raised some questions in-house. First, whether you should reconsider going through with the appearance, now that we know that Jerry Wiesner, who cannot attend the meeting, is to be replaced by Derek Bok or (from Knight's telephone conversation with me) Bill Ward of Amherst. Herb Hetu and John Waller believe that you should have another chance to consider your acceptance of the invitation. Second, who should be your replacement in the 1:5 chance that you are unable to meet the commitment. Knight indicated to me that the AAUP choice would be Tony Lapham. Tony, however, has a long-standing engagement that will make him unavailable. Mr. Carlucci will also not be available as he has an overseas trip planned for that period. John Waller says that he will be the replacement if you want him to be but he strongly urges that your replacement should be someone who is in a better position to speak publicly for the Agency and the Intelligence Community. He would recommend, therefore, that if you cannot meet the appointment, Mr. Carlucci not being available to replace you, it is better that no one from the Agency attempt to take your place. His thought, of course, is that with the question of "guidelines" coming up at various universities and colleges around the country

SUBJECT: Reply to letter from Morton S. Baratz, General Secretary, American Association of University Professors, re your participation in a panel discussion at the association's annual meeting in New Haven, 10 June 1978

(currently at Amherst, California, Columbia, M.I.T., and Pennsylvania -- to our knowledge, there may be others), this panel might attract press and public attention so that whoever speaks for the Agency should do so with the highest authority.

3. Action Recommended: Signature on the attached letter to Morton S. Baratz. If the reply does not satisfy you, I suggest you may wish to discuss it with Hetu, Lapham, Waller and/or myself. I have cleared this memo with Hetu and Waller.


Dear Admiral Turner:
