NEMORANDUM FOR THE RECORD

SUBJECT: Amendment No. 3 to Contract No. FI-3011 with Westinghouse Electric Corporation, Baltimore, Md., Project EQUINE (AQUATORE)

- 1. This memorandum contains a recommendation submitted for approval of the Director of Central Intelligence. Such recommendation is contained in Paragraph 5.
- 2. Contract No. FL-3011 provides for the design, fabrication and delivery of certain rader equipment for use in aircraft under the subject project. Amendment No. 1 thereto, covers the design and fabrication of two low altitude antennas for use under program. Amendment No. 2 to the subject contract provides for installation of the first radar mapping set being produced under the contract in the Contractor's DC-3 aircraft, flight testing the equipment, and training pilots in the operation of the equipment over a period of approximately six weeks. This Amendment No. 3 covers procurement of additional radar equipment and spare parts for Project AQUATONE and Project and four (4) radar equipments for the Department of the Air Force. Amendment No. 3 also restates the centract work into equipment requirement groups for the respective activities in order to facilitate administration of the contract.
- 3. The total contract price of Contract No. FL-3011 and Amendments Nos. 1 and 2 thereto is \$1,269,503, funds for which have been obligated, in the amounts indicated, from the following allotments: \$1,129,854 of Fiscal Year 1956 AQUATOME funds and \$139,649 of Fiscal Year 1956 funds chargeable to Allotment 6-2119-52-020, Project Admendment No. 3 increases the contract price By \$1,847,142 from \$1,269,503 to \$3116,645. By reason of Amendment No. 3, funds previously obligated under the contract are to be adjusted and funds transferred to the Agency from the Department of the Air Force are to be added to the contract to reflect the following revised obligations:
  - \$1,081,126 Fiscal Year 1956 AQUATOME funds chargeable to Project EQUIME.
  - 1,510,448 Fiscal Year 1956 funds, chargeable to Air Maritime Division Allotment 6-2119-52-020, Project
    - 525,071 Fiscal Year 1956 funds chargeable to Appropriation 21%6889 for Project EQUINE/AF (Funds transferred from the Department of the Air Force).

The above adjustment in fund obligations between Project AQUATOME and Project \_\_\_\_\_\_\_\_ vill reduce the amount previously obligated under the contract out of Fiscal Tear 1956 AQUATOME funds from \$1,129,854 to \$1,081,126, resulting in \$48,728 of Fiscal Year 1956 AQUATOME funds becoming available for other contractual obligations within the ourrest fiscal year.

- 4. By memorandum dated 29 July 1955 from the Director of Central Intelligence to the Comptroller, and in accordance with the provisions of Section 10(b) of Public Law 110, the Director of Central Intelligence has certified that the sum of \$3,500,000 is available for expenditure for Project ECUINE.
- 5. Approval of Amendment No. 3 to Contract No. FL-3011 and execution thereof on behalf of the Agancy by the authorized Project Contracting Officer is recommended.
