1. [ ] called regarding Senator Fulbright's press conference on Friday, 30 January 1959. For purposes of [ ] this information, they were trying to get an authenticated report of what was said. He wondered if such a report might be forthcoming from the Senator's office or whether there was a transcript. Upon checking with the Senator's office, it was learned that there was no prepared report or transcript available. It was entirely off-the-cuff and no one seemed to have a complete record. [ ] was so advised.

2. The resumption of the briefing by the Director before the House Foreign Affairs Committee was confirmed for 2:30 on Tuesday, 3 February 1959 with Mr. Boyd Crawford's office (Mrs. Louise O'Brien.)

3. Personnel [ ] called to advise that a letter was going forward today to [ ] regarding his application for a position with the Agency. This will be a reject due to organizational changes, etc. They called to give us the information as they felt [ ] would contact Representative George Huddleston, Jr. (D., Ala.) as he had been referred by the Congressman's office.

4. Met with [ ] to discuss the various measures for a Joint Committee pending in the House Rules Committee. See Memorandum for the Record.

5. The DCI briefed the Defense Appropriations Subcommittee of House Appropriations in the morning and afternoon. (See Memorandum for the Record dated 3 February 1959.)

6. Talked with Boyd Crawford of House Foreign Affairs who was calling to inquire if the Agency could not bring up a one-page statement to be released to the Press. The Chairman had noted a news item concerning the Director's speech on 30 January and requested the matter be raised with the Agency in view of the insistent inquiries of the press. Subsequently this was discussed with the Director who was agreeable and a draft release was furnished to the Committee.
