

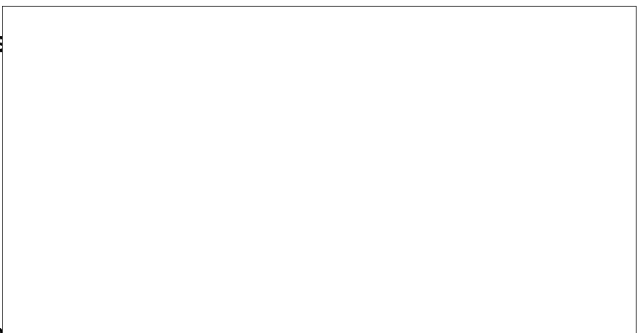

A. COMPLETED PROJECTS

1. FE Preliminary Estimate

The Preliminary Estimate of the [redacted] has been reviewed. No significant training implications were noted. Appropriate comment has been submitted to the SPA-DD/S.

2. Presentation at Naval War College
