MEMORANDUM FOR: Deputy Director (Plans)

SUBJECT: Request of Mr. Homans for Authorization to
Discuss Psychological Warfare with
O/PC

1. On 8 January Mr. George C. Homans and Lieut. Commander Mosel, both of the Research and Development Board, came to my office for help in obtaining the necessary authorization for Mr. Homans to discuss (a) with [] the research [] is doing in support of psychological warfare, and (b) with O/PC the kinds of psychological operations in which they engage.

2. Mr. Homans is the chairman of the recently formed Ad Hoc Committee on Psychological Warfare of the Research and Development Board. The tasks assigned his committee as he explained them are:

a. To survey the research now being done in support of psychological warfare whether within the Government or by outside institutions.

b. To recommend what research not now in progress should be undertaken.

c. To recommend what mechanism(s) should be used to control or monitor research in this field.

d. To investigate how research is being used in psychological operations and endeavor to make it more useful.

3. The membership of the Ad Hoc Committee, besides Mr. Homans, is as follows:

4. I understand that Mr. Homans has an interim clearance for TOP SECRET from the RDB. IAS considers this clearance sufficient for the arrangements recommended below. Mr. Homans was recently offered a job

5. Mr. Romans recognizes the sensitive nature of CIA psychological operations and agrees that any information he receives will not be passed on to the other members of his committee. He points out, however, that in order for his committee to be really useful in guiding psychological research, its chairman must be familiar in general terms with the types of PW operations in which O/PC engages. He does not need to know of specific operations in progress or planned.

RECOMMENDATIONS:

1. That you authorize O/PC to discuss their psychological operations with Mr. Romans in general terms.

2. That Mr. Romans not be authorized to contact [] directly but that O/PC be authorized to discuss [] psychological warfare projects with him and to bring [] as appropriate.
