SUBJECT: Foreign Service Reports

DATE: December 1, 1954

Foreign Service reports of cases of DCN interest may roughly be broken down in the following four categories: (1) trade in commodities of US origin; (2) trade by US or US-controlled firms and/or individuals; (3) offers of controlled and non-controlled commodities not covered by categories (1) and (2); (4) completed diversion arrangements not covered by categories (1) and (2).

Re category (1) Commerce action: Commerce should attempt to keep other interested agencies informed as to what action is taken. Note: It is particularly important to keep other possibly interested agencies informed in cases where Commerce should decide not to take action, as for instance, where the commodity turns out not to be of US origin. The case then automatically would become the concern of the Department of State and/or FDA/NDAC.

Re category (2) Treasury action: As in the case of category (1) it is important that Treasury keep other agencies posted as to the action taken by Treasury. Also, when Treasury decides to take no action, as for instance, where the firm involved turns out to be one not controlled by US interests.

Re category (3): This category covers a wide variety of cases, and as often as not no ^{immediate} ~~initial~~ action will be required. In the cases where no immediate action is required, it will still be important to keep record of the commodities as well as the firms involved, and this function would naturally be one that CIA would be best equipped to perform. After an analysis of such cases CIA may then be prepared to make recommendations for later action on a more consolidated basis. Such recommendations may, e.g., include administrative action or entry on the BFC Check List.

Re category (4): These cases will ordinarily require State Department action, although any agency may suggest action.
