INTERNATIONAL CHINA EMBARGO LIST

CHINA COMMITTEE

1. Attached hereto is the "China Special List," revised as at 30th November, 1953. This supersedes Doc. CH/170. It includes all items agreed by the Committee, as at the date above, for embargo to China and North Korea, in addition to the items on International Lists I, II, and III.

2. The "Source" column in the List shows, for each item, the Documents recording agreement on the definition as listed. Where the source is a China Committee Document, the symbol "CH/-" is used; where the source is a COCOM Document, the symbol "Doc -" is used. In addition, for items originating from the proposals in COCOM Document 509 (and Addendum), the numbers subsequently assigned to them by COCOM Document 782 (Annex) are shown in parentheses.

3. All definitions in the attached List (whether or not marked "n.e.s.") should be construed as exclusive of all types and varieties covered by the International Lists.
