1. Accomplishments.

A. Branch Projects Submitted --

B. Status of Projects --

30.1535 -- Industrial Capital Investment in Communist China.
An edited draft copy has been retyped. I intend to work on this project as soon as the Soviet NIE is completed.

30.2043 -- Capital Investment in the Producers' Equipment Industry in Communist China. Six basic research chapters are completed in draft form. Two others are expected to be completed by the end of July. A final basic chapter will probably be ready in early August. Material prepared up to the latter part of July will be given a preliminary review in the branch at that time. Recently acquired data on investment indicate the possibility of significant findings on the proportion of machine-building capacity devoted to military production, and, hence, the potential contribution of the present diversion of production capacity in military industries to civilian uses. Rigorous exploitation of these data is deemed necessary and justifiable, but this would probably not cause a delay of over two weeks.
