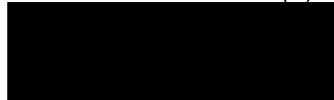

5. The check should be dated 10 January 1956 and when it has been drawn, please contact the undersigned on Extension 2981.



