MEMORANDUM FOR THE RECORD

SUBJECT: ORR/CIA Contribution to Library of Congress Report on East-West Trade

1. [redacted] and I discussed the outline for the Library of Congress Report on East-West Trade with [redacted] on Thursday, 11 June 1964. This report is being prepared for Senator Fulbright's Committee on Foreign Relations. He asked that CIA prepare text or comment on every section of the outline except where we might be limited by the security classification of our information, intimating that the Agency had the only genuine expertise among government organization on which he would have to rely. [redacted] indicated that the CIA contribution could take the form of tabulated data and commentary or a formal chapter on any section of the outline undertaken. We mutually agreed that our contribution would be drawn from research which had been completed or was presently in process rather than make an effort to do additional research for this report. He indicated Agency contributions should reach him by 17 August 1964.

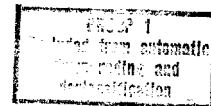
