25X1A9a D/A: Messrs. [REDACTED] attended a meeting of the SPECIAL COMMITTEE ON EAST-WEST TRADE (NSC). Highlights of the meeting are listed below:

Mr. Harold Linder, STATE, REPORTED ON the recent NEGOTIATIONS REGARDING the ADDITION TO INTERNATIONAL LIST I OF PREVIOUSLY NON-AGREED ITEMS. THIRTY-FOUR ITEMS WERE ADDED TO THE LIST, leaving 19, including rubber and tin, still on the US List IA. Some of these will be added to II II with stricter quantitative control.

Comments EXCEPTIONS TO the KEM AMENDMENT WERE RECOMMENDED IN THE CASE OF GREECE, IRAQ, LEBANON, SYRIA, AFGHANISTAN, AND BURMA. The CIA representative recommended the deletion of *certain* and their inclusion in the classified supplement. This was agreed in part.

A progress report on certifications by the Latin American republics was submitted by State. A majority of the countries are expected to be able to make certification as required by Kem Amendment. It may be necessary to ask exceptions in the case of Argentina, Brazil, Chile, and Peru, and possibly some others.

THE MEMORANDUM OF THE DRAFTING SUBCOMMITTEE ON THE TRANSHIPMENT OF CHILEAN COPPER WAS APPROVED.

It was AGREED THAT the NATO COUNTRIES WOULD BE CONSIDERED AS A GROUP IN MAKING A DETERMINATION UNDER THE KEM AMENDMENT.

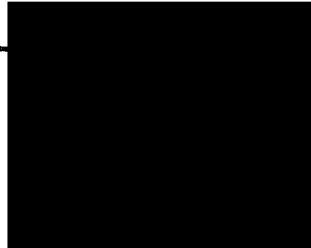
