2. Mr. [redacted] a GS-11 staff employee, entered on duty at [redacted] in July 1962. He shipped 5,040 net pounds and stored 220 pounds. His total entitlement is 10,000 pounds. In mid-tour he was transferred from [redacted]. He completed his first overseas tour of two years and five months on 7 November 1964 and will be starting his second tour in [redacted] on 4 January 1965. Mr. [redacted] is now at Headquarters on TDY prior to home leave. While he is here, he wishes to purchase some items of furniture and to ship the 220 pounds which he has stored to [redacted]. Total net weight of the items to be purchased and those items in storage to be shipped will approximate 1,000 pounds net.
