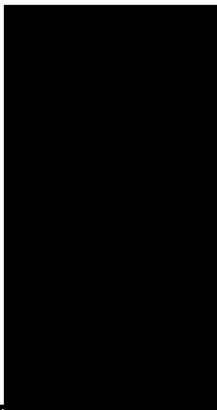

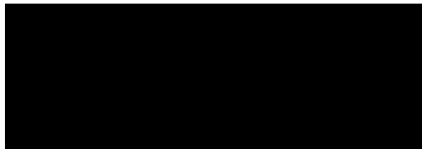

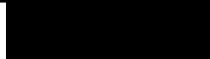

Mr. McCone has asked that I answer your letter of 26 February on his behalf.

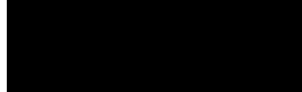
