# FBI Frustrated in Search for Anti-Red Leader

Family of Eight Dis appeared 16 Month Ago—Car Found

Phe mysterious disappearan 16 months ago of John R. Harrel and seven members of his famil has been a frustrating case for the Federal Bureau of Investiga tion, which has had as many a 100 agents working on it at on time, an authority connected with the search told the Post-Dispatch yesterday.

Harrell was the wealthy leade of the anti-Communist Christia Conservative Church. His auto mobile was found on a side road near Springfield, III., April 1 1963. He was reported to have been carrying between \$14,00 and \$20,000 at the time of his disappearance.

## Friend Believes Harrell Is Held by Communists or CJA

Shortly after Harroll's disappearance, DePugh offered a reward of \$5000 for information about the family's whereabouts. DePugh, Norborne, Mo., is president of Biolab Corp., a pharmaceutical firm.

Questioned by FBI

DePugh said the FBI has questioned him many times about Harrell's disappearance. "FBI agents try to leave the impression they believe John is hiding out," DePugh said.

At the time of his disappearance, Harrell was en route to Springfield for a conference with officials of the Internal Revenue Service about income tax problems. Harrell operated a mausoleum and construction business.

"There are two reasons why rells are hiding out somewhere," DePugh said:

"(I) They left their baby behind. I know of an instance in which John and his wife went on a vacation without the children. After four days, she insisted they cut the vacation short and return home because she missed the baby and was worried about him. It doesn't make sense that they would leave the baby for a year and four months.

"(2) John's mother was with him. I could conceive that he might have felt himself in danger and that there was so much pressure against him that he would hide out, but his mother was a hard-headed old business lady who was not the type to have anything to do with any voluntary disappearance.

"People who knew John also have said it was his handwriting," DePugh related, "I don't com-pletely discount the possibility it was a forgery. It could be that he was dead and somebody wanted the authorities to think, for some reason, that he was still alive.'

## Lists Possible Abductors

Only three organizations in this country-the FBI, the Central Intelligence Agency and the Communists—are capable of "so completely hiding a man, two women and five children for such a long period of time," Depugh asserted.

"The FBI would never be a party to such a trick, and there's no reasn why it should be, so that leaves the other two," De-Pugh said.

He said that the Communists he would not eliminate the CIA from suspicion because "it has come under Communist influence."

DePugh said that the CIA "has exceeded its grant of authority. It was established to operate outside the United States. The FBI has jurisdiction within the United States. The FBI, relatively speaking, is a patriotic organization. It is trustworthy.'

"John Harrell wasn't the fanatic a lot of people thought," DePugh said. "I know the Communists considered him danger-

#### Tells of Hideout

"Some time before his disappearance, John had bought a hideout and about \$100,000 worth of food, general supplies and military equipment, inculding several hundred rifles and a large quantity of ammunition. I don't know where the hideout was, but I would guess it was in New Mexico."

DePugh was highly critical of the Federal Government for its "long delay" in beginning an investigation of the disappear-

"John's friends asked the FBI to investigate, and they said it was beyond their jurisdiction until they finally came into the case some seven months after he and his family disappeared." DePugh said.
