SENTENCING OF CUBAN

(SUMMARY) IN NEW YORK A MINIMUM PRISON SENTENCE OF 20 YEARS HAS BEEN IMPOSED ON FRANCISCO MOLINA DEL RIO. THE WORLD KNOWS THAT FRANCISCO MOLINA IS INNOCENT OF THE CRIME FOR WHICH HE WAS CHARGED AND THAT IT WAS CONSERVATIONARY ELEMENTS DIRECTED BY MR. KENNEDY'S CENTRAL INTELLIGENCE AGENCY. THE WORLD KNOWS THAT THE YANKEE STATE DEPARTMENT WISHED A SCANDAL TO DEFLECT THE POSSIBLE CHARGES MADE BY FIDEL IN THE U.S. ASSEMBLY AGAINST IMPERIALISM, COLONIALISM, DEPOTISM, RACIAL SUPREMACY DOCTRINES, THE U.S. WAR HYSTERIA, U.S. AGGRESSION AGAINST LATIN AMERICA, AND EXPLOITATION OF MAN BY MAN.

THE WORLD KNOWS THAT THE JUDGMENT AGAINST FRANCISCO MOLINA DEL RIO IS A FARCE AND GROTESQUE COMEDY, A MOCKERY OF JUSTICE AND LAW. THE WORLD KNOWS THAT THE JUDGES WHO A FEW HOURS AGO SENTENCED MOLINA DEL RIO TO 20 YEARS IN JAIL ARE MERELY RUBBER STAMPS OF THE YANKEE MONOPOLIES AND THE REACTIONARY GOVERNMENT OF MR. KENNEDY.

"THE WORLD KNOWS WHY THESE JUDGES HAVE CONDEMNED FRANCISCO MOLINA DEL RIO. MR. KENNEDY AND HIS MEMBERS OF THE CENTRAL INTELLIGENCE AGENCY HAVE WANTED TO TAKE REVENGE IN THIS MANNER FOR THE HUMILIATING DEFEAT AT PLAYA GIRON. MR. KENNEDY AND THE CENTRAL INTELLIGENCE AGENCY HAVE WANTED TO REPLY TO THE ACHIEVEMENTS OF THE CUBAN REVOLUTION IN EVERY FIELD.

MR. KENNEDY COULD NOT DEFEAT US AT PLAYA GIRON. THIS HE WANTED TO ACHIEVE VICTORY IN NEW YORK. BUT MR. KENNEDY MUST KNOW THAT FRANCISCO MOLINA DEL RIO WILL NOT SERVE 20 YEARS IN A YANKEE PRISON. IMPERIALISM WILL NOT LAST THAT LONG. THE DOORS WHICH TODAY HAVE CLOSED BEHIND FRANCISCO DEL MOLINA WILL BE REOPENED MUCH EARLIER "BECAUSE OF THE DESIRE OF THE PEOPLES OF LATIN AMERICA AND OF THE WORLD."
