Having no other alternative, I am taking the liberty of seeking your help in a private matter.

I was married to a former CIA employee who retired on medical grounds in the spring of 1972.

We were divorced in 1968 at which time he voluntarily agreed to pay me alimony.

As soon as his retirement became effective, he moved to whereabouts unknown and stopped his payments which I am in dire need of.

Three times since his disappearance he has appealed to the D.C. Court for cancellation of his alimony payments but twice the initial judgment was confirmed and the third decision is still pending at the present time.

I am now faced with legal fees which make my financial position disastrous.

My lawyer has repeatedly and unsuccessfully tried to locate him in order to make him face contempt of court charges but all his enquiries were met with secrecy.

Is it not unfair that the fact that he once belonged to your Organization puts him above the law?

I do need your help. Please let me have his address so that this matter may be pursued the way the law has repeatedly decreed.
