A. MOVEMENTS OF TRAINEES WILL BE RESTRICTED TO HANGER 1 FLOOR, HANGER 2, HANGER 2 AND ONE HALF, LUNCH ROOM, ADMIN OFFICE, COFFEE BAR IN DM AREA AND LAUNCH AREAS TO INCLUDE THE RUNWAY ITSELF.

B. TRAINEES WILL BE ESCORTED BY ONE OF THE THREE SAC I-3 TYPES CURRENTLY IN TRAINING STATUS HERE.
