PURCHASE THESE LOCALLY (IF AVAILABLE). HE MUST CLEAR THIS FIRST WITH ME. WHEN I INITIATED THIS, I REALIZED THIS MIGHT RESTRICT [REDACTED] 25X1A TO SOME DEGREE IF HE HAD MANY REQUESTS. HOWEVER, DUE TO PAST EXCESSIVE USE OF FUNDS FOR MEDICINE I STRONGLY FELT THIS WAS NECESSARY. THIS WAS DISCUSSED WITH [REDACTED] AND HE UNDERSTOOD THE 25X1A RATIONALE AND WAS MOST AGREEABLE TO THE SYTEM. HE INDICATED THAT HE TOO, WAS INTERESETED IN AN EFFICIENT OPERATION AND REQUESTED A MICROSCOPE TO DO HIS OWN ROUTINE LAB WORK SO HE WOULD NOT HAVE TO WAIT FOR THE LAB REPORT.
