25X1 1. (Secret - JMM) Accompanied the Director and Messrs. [redacted] Carver, [redacted] to a briefing of the Defense Subcommittee of Senate Appropriations Committee. See Memo for Record.

25X1 2. (Confidential - JMM) [redacted] and I lunched with Bill Woodruff, Counsel, Senate Appropriations Committee, who said that as soon as the Director felt he was settled into his responsibilities as "Tzar" of the intelligence community they would like him to appear before the Intelligence Subcommittee to discuss community budget matters. He said they would not expect him to have exercised much of his new authority regarding the FY 1973 budget for the other agencies, but they would be interested in knowing his plans for coping with the FY 1974 budgets of these agencies.

3. (Confidential - JMM) Carl Marcy, Staff Director, Senate Foreign Relations Committee, called to say that he had learned from an RFE official of a classified study prepared by the Agency estimating the costs and problems of terminating our Radios. He said he wondered whether it would be possible to get a look at this study, parts of which had already been quoted by the RFE representative to the Committee, and he said they would be glad to handle it on a classified basis. I said I would look into it.

4. (Unclassified - JMM) Talked to Jane Havlicek, in the office of Representative Barry Goldwater, Jr., regarding his interest in visiting the Agency. She said his schedule was extremely tight and they would have to call me back, probably to arrange a breakfast meeting a few weeks hence.

5. (Unclassified - GLC) Hand-carried to Miss Janet Harris, on the staff of Senator John Tunney (D., Calif.), a suggested reply and backup material for a response to an inquiry the Senator had received from Antony C. Sutton on the allegations that Chou En-lai was involved in the massacre of a family of six in the early 1930s. Miss Harris was most grateful for our assistance.

6. (Secret - RJK) Delivered to Edith Jack, JCAE Staff, 25 copies (nos. 6-30) of the Director's prepared statement for his briefing of the Committee tomorrow.

7. (Unclassified - GLC) Picked up from Mr. Cecil Presson, Senate Internal Security Subcommittee, the revised page proofs of "Soviet Intelligence and Security Services 1964-70 - A Selected Bibliography of Soviet Publications with Some Additional Titles from Other Sources." This was passed to  for review and correction.

8. (Confidential - GLC) George Murphy, Joint Committee on Atomic Energy staff, called and noted that the prepared statements for the Director's briefing of the Committee tomorrow did not include certain areas which the Director had previously covered in his testimony. He mentioned specifically Cuba. I told Murphy I thought the Director had tried to limit his prepared statement to those matters of special interest to the Committee in view of the fact that the session was scheduled for the afternoon only, but I was sure he could respond to any questions which the members might have in other areas.

Murphy said the Director might receive a question about the Washington Post item of February 13 which stated that Russia and China were involved in a near nuclear confrontation in 1969. I have alerted Dr. Chamberlain and we will mention this to the Director.

9. (Secret - JMM) Accompanied Mr. Karamessines to meet with Senator Strom Thurmond and Mr. Dan Carrison of his staff regarding a matter about which the Senator had inquired of the Director. Mr. Karamessines explained the situation to the Senator's apparent satisfaction and it was agreed that if we got any further information on the subject we would share it with the Senator.

(See Journal for 10 February) The Director of Personnel was advised and [redacted] Finance Division, is forwarding us a copy of the study and updating the figures in out 26 June 1970 letter to OMB on this same subject.

I made Miss Adams aware of our no comment policy and offered to prepare a suggested reply for the Senator, and she said she would appreciate this.
