SUBJECT : Romanian Trade in Selected Agricultural Products and Machinery

1. Enclosed are the tables showing Romanian trade figures for agricultural products and machinery. Romanian currency was converted to U.S.\$ using the foreign-exchange rate prevailing at the given year.

2. The Romanian yearbook series has many gaps in data. Imports of grains, except rice, are not listed; only during the 1970 flood, however, is there any indication that significant imports took place. Additionally, commodity breakdowns are not available for trade in agricultural machinery except the export of tractors, a product the Romanians push.

(Unclassified - JGO) Received a call from Fran Christy, Staff Assistant, House Judiciary Committee, who asked for a copy of the Agency Guide to CIA Statutes and Law, published by the Office of the General Counsel, for Garner Cline, Counsel.
