1. USAID HAS GIVEN MOST THOROUGH REVIEW TO MATTERS POSED IN REF A IN LIGHT OF POLICY OBJECTIVES THERIN AND IN FURTHERANCE OF ASSURANCES AND OBJECTIVES SET OUT BY AMB MARTIN. PARTICULAR CONSIDERATION HAS BEEN GIVEN TO SENATE APPROPRIATIONS COMITE REPORT. THE MISSION ACTIVITIES AND GROUPINGS RELATING TO POLICE AND PRISONS CONTAINED IN REF A PARAS 3 AND 4 ARE ANALYZED UNDER THE FOLLOWING HEADINGS:

CONTRARY TO ASSUMPTIONS OF REF A PARA 3-A, PM/CC COULD BE PURGED OF NP SUB-SYSTEMS SINCE NP USES COMPUTER TO EXTRACT DATA FROM NP SUB-SYSTEMS APPROXIMATELY 20 PERCENT OF TOTAL COMPUTER TIME AVAILABLE. CONTRACT AID 730-3618 PROVIDES ELEVEN ADVISORS FOR DEVELOPING INSTRUCTORS TO TRAIN PROGRAMMERS AND SYSTEMS ANALYSTS FOR GVN TO HAVE ONGOING COMPETENCE. CALSS #2 FOR SYSTEMS ANALYSIS WAS COMPLETED DURING NOV 73 AND WAS LAST CLASS WHICH CONTAINED NP PARTICIPANTS FOR SYSTEMS ANALYSTS INSTRUCTORS/TRAINERS. CLASS #6 FOR TRAINERS AS PROGRAM INSTRUCTORS ENDED JANUARY. THIS WAS LAST CLASS FOR PROGRAMMER INSTRUCTOR TO INCLUDE ANY NP PARTICIPANTS. THESE CLASSES NOT COMPRISED SOLELY OF NP WHO CONSTITUTE SMALLEST GVN AGENCY PARTICIPATION. PLEASE NOTE NP HAVE OWN PROGRAMMING. SYSTEMS ANALYSIS, PRODUCTION CONTROL AND DATA PREPARATION PERSONNEL ENTIRELY DISTINCT FROM PM/CC AND RELY ON PM/CC ONLY FOR ACTUAL COMPUTER PROCESSING OF NP APPLICATION (TO EXTENT 20 PERCENT NOTED).

AID 730-3519 PROVIDES EIGHT TECHINCIA NS TEACHING PM/CC COMPUTER MANAGEMENT. NO NP ASSISTANCE INVOLVED.

AID 730-3486 PROVIDES SIX TECHNICIANS FOR TRANSFERRING SYSTEMS TO PM/CC. THERE IS NO ASSISTANCE TO NP IN REMAINDER OF THIS CONTRACT.

COMPUTER SCIENCES CORP. PROVIDES 48 TECHNICIANS, 37 US AND 11 VIETNAMESE. ONLY ONE TASK ORDER, #7, IN THIS CONTRACT, INVOLVING 11 PERSONS, ASSISTS NP IN DOCUMENTATION OF FIVE OPERATIONAL SYSTEMS AND DEVELOPING TWO OTHER SYSTEMS. REMAINING TASK ORDERS DEALING WITH MANAGEMENT OF CONTRACT, WAR VETERANS SYSTEMS, CENTRAL RECONSTRUCTION DEVELOPMENT COUNCIL IN PRIMINS OFFICE, TECHWRITING ASSISTANCE AND PRODUCTION CONTROL DO NOT RELATE TO POLICE AT ALL.

AID 730-3618 TERMINATES NOV 8, 74; AID 730-3519 TERMINATES AUG 20, 74 AID 730-3486 TERMINATES AUG 3, 74; AND COMPUTER SCIENCES CORP. CONTRACT TERMINATES JUNE 13, 74. NONE OF CONTRACTS WILL BE EXTENDED EVEN THOUGH NO ASSISTANCE TO POLICE INVOLVED.

4. PLANS.

RE CONTRACT SERVICES TO PM/CC USAID PROPOSES TO CARRY THESE FOUR CONTRACTS TO COMPLETION, WITH IMMEDIATE NOTICE OF PARTIAL TERMINATION OF ONE CONTRACT TO ELIMINATE ASSISTANCE TO POLICE TRAINING. AID 730-3618 (COMPUTER INSTRUCTORS TRAINING TEAM) REQUIRES ADDITIONAL \$207,524 TO BRING THIS CONTRACT TO TERMINATION IN NOV 74. WITH TERMINATION OF TASK ORDER #7 OF COMPUTE BSCIENCES CORP. CONTRACT, ALL POLICE INVOLVEMENT IS ENDED THIS MONTH SO THAT REMAINDER OF CONTRACT PROVIDES TRAINING TO ASSIST GVN OFFICE OF PRIMIN TO OPERATE THE COMPUTER CENTER. USAID HAS INVESTED OVER \$2 MILLION IN PM/CC PROJECT AND THE GVN INPUT EXCEEDS THIS, HAVING USED GVN FOREIGN EXCHANGE TO PURCHASE THE COMPUTER. CANCELLATION OF THE THREE SEACA CONTRACTS, WHICH INVOLVE NO FURTHER POLICE ASSISTANCE, COULD RESULT IN FAILURE OF THE PM/CC. FURTHER, WHILE IMPOSING AN INCONVENIENCE USAID WILL INSIST THAT THE NP TRANSFER DATA EXTRACTION TO ANOTHER COMPUTER

LEAVING THE PM/CC WITHOUT ANY POLICE USE.

COMPUTER SCIENCES CORP. CONTRACT IS THREE YEAR CONTRACT FULLY FUNDED BY DOD TO ITS TERMINATION JUNE 13, 74. THE NP COMPONENT OF THIS CONTRACT, WORK ORDER #7, IS SEVERABLE AND HAS SOME \$158,000 OBLIGATED AS OF 12/31/73 TO CARRY IT TO COMPLETION. NONETHELESS, THIS TASK ORDER IS BEING CANCELLED ON 30 DAYS NOTICE SO THAT ALL DIRECT AND INDIRECT POLICE INVOLVEMENT IN THE PM/COMPUTER CENTER IS ELIMINATED. THE SENATE COMITE REPORT MADE NO MENTION OF THE PM/COMPUTER CENTER.

THE TWO CONTRACTS FOR CTD ARE FULLY FUNDED AND EXPIRE 3/31/74. IT WOULD BE COSTLY TO TERMINATE FOR CONVENIENCE, (WOULD REQUIRE 30 DAYS TO BRING ABOUT TERMINATION WHICH WOULD BRING US OUT TO THE END OF FEBRUARY) WHEREAS THESE CONTRACTS END A MONTH LATER ON MARCH 31, 74.

**B. DIRECT HIRE AND PERSONAL SERVICE CONTRACT TECHNICIANS:**

**1. ACTIVITIES AND STATUS.**

TWO DIRECT HIRE AND TWO PS TECHNICIANS ARE ASSIGNED TO THE PM/CC. THEIR FUNCTIONS ARE RELATED LARGELY TO MONITORING THE CONTRACTS DISCUSSED UNDER A. THEY ARE NOT INVOLVED IN ASSISTING THE NP. ONE DH POSITION IS SCHEDULED FOR ELIMINATION IN JUNE 74 AND THE SECOND IN SEPTEMBER 74. CAE PS CONTRACTORS ARE SCHEDULED FOR TERMINATION: ONE IN JUNE 74 AND THE SECOND IN NOVEMBER 74.

FIVE DH USAID ADVISORS ASSIST CTD (FORMERLY NINE, FOUR DEPARTED, NO REPLACEMENT INTENDED). THESE DH SERVE AS TRAINING OFFICERS, MONITOR CONTRACTS, AND ASSIST IN COMMODITY SUPPORT. NO PS TECHNICIANS IN CTD. IT IS PLANNED TO PHASE OUT THE FIVE DH BY 3/31/74.

THERE IS NO TRAINING OF POLICE IN THIRD COUNTRIES AND NO POLICE TRAINING IN VIETNAM OTHER THAN THE CONCLUDING ACTIVITIES DISCUSSED UNDER CONTRACT SERVICES IN A ABOVE AND THE PREPARATORY ENGLISH LANGUAGE TRAINING DISCUSSED IN C4 ZOLOW. ALL PARTICIPANT TRAINING DISCUSSED HEREIN IS AID FINANCED.

UNDER FY 74 FUNDING, FIVE NP COMPLETED TRAINING IN OCT 73; TWELVE ARE STILL IN TRAINING IN THE US, FOUR TO RETURN JAN 74; SIX TO RETURN APRIL 74; AND TWO TO RETURN JUNE 74. FOUR NP FOR WHOM FY 74 FUNDS ARE OBLIGATED HAVE NOT GONE; ONE MISSED PROGRAM AND FUNDING WOULD BE CANCELLED IN ANY CASE AND THREE OTHERS DID NOT QUALIFY FOR OTHER REASONS NECESSITATING FUNDING CANCELLATION.

ADP - COMPUTER TRAINING - UNDER FY 73 FUNDING, 37 NP PARTICIPANTS COMPLETED TRAINING AND 18 ARE STILL IN TRAINING, 12 TO COMPLETE COURSES IN FEB 74 AND 6 TO COMPLETE COURSES IN JULY 74. 4. PLANS. USAID IS ADVISED AND FULLY AGREES THAT PARTICIPANTS PRESENTLY IN TRAINING IN THE STATES SHOULD COMPLETE THEIR TRAINING BEFORE RETURNING TO VIETNAM. WITH RESPECT TO TWENTY PARTICIPANTS AWAITING CALL FORWARD FROM VIETNAM, USAID IS CANCELLING THE PROGRAM FOR THESE PARTICIPANTS DESPITE THE HARDSHIP IT CAUSES THE INDIVIDUALS AND THE POSSIBLE MISUNDERSTANDING BY THE GVN. ALL OTHER NP TRAINING PLANS ARE CANCELLED. RELATED TO THE PARTICIPANT TRAINING PROGRAM BUT NO DIRECTLY A PART OF IT ARE THE ENGLISH LANGUAGE CLASSES CONDUCTED FOR GVN OFFICIALS IN THE STAFF DEVELOPMENT CENTER (SDC).

THERE ARE PRESENTLY 74 NATIONAL POLICE OFFICERS ATTENDING ENGLISH CLASSES. THIS TERM ENDS FEB 8, 74. THESE ARE SOME OF THE ASPIRANTS FOR THE GENERAL POLICE TRAINING OF 64 PARTICIPANTS AT IPA AND 200 PARTICIPANTS IN COMPUTER MANAGEMENT PROGRAMMED FOR FY74 WHO ARE ELIMINATED UNDER THE CURRENT REVIEW. AS TO PROVIDING
