- 1. I talked to Dr. Tietjen again this morning about the possibility of more active participation by him in the Intelligence Community effort. Following an earlier discussion with Bob Bannerman, it seemed to me that the Agency has unique experience and expertise in the screening and handling of personnel for sensitive intelligence work. It seems obvious that no one else in the Intelligence Community can offer us any competition and that, even if they had the knowledge, they might be prevented by regulation or law from giving proper attention to these cases. I asked John to give some thought to this suggestion while he is on his trip and to see whether he could come forward with some concrete proposal wherein we might be able to offer the benefit of our experience and expertise to the Community with the possible ultimate objective of developing higher and more uniform standards throughout the Community. He was appreciative of this suggestion and said that he certainly would give it some more thought. (I also want to discuss this idea with General Carter.)
- 2. Bob Bannerman, Howard Osborn, and I discussed the Department of State's interest in starting a polygraph program. We all agreed that we could not under any circumstances polygraph Department of State applicants or employees for them but that we should offer assistance in the development of a program. To this end, I undertook to invite Bill Crockett, Dwight Porter, and Marv Gentile out for lunch, at which time we could discuss this subject.
