10. (Unclassified - DFM) LIAISON Called John Seibert, Special Litigation Section, Criminal Division, Department of Justice. [Redacted] OGC, gave me Mr. Seibert's name and encouraged me to call him. I explained to Seibert that we had received a congressional inquiry on behalf of a constituent for the names of all plaintiffs suing the Agency over our domestic activities. I asked Seibert if there would be any Justice Department position or objection to us providing the names. After checking with some colleagues, Seibert phoned back and encouraged us to release the names, explaining that they were a matter of public record.
