SUBJECT: Amendments to Standardized Government Travel Regulations

Attached revision of Appendix I of the Standardized Government Travel Regulations, setting forth the maximum per diem rates for travel beyond the limits of the continental United States, rescinds the revision of Appendix I as promulgated with Transmittal Memorandum No. 5, dated October 25, 1957, to Budget Circular No. A-7 dated June 22, 1956. Changes in rates are identified by asterisks. The new revision becomes effective June 1, 1958.
