

3. Agency Regulation  permits the transfer of Staff Employees to a Contract status, as follows:

a. 1.a.(5):

"a. The Central Intelligence Agency may engage individuals by contract:....

"(5) When the individual's primary employer or interest is not the Central Intelligence Agency and the services the Agency desires from him are supplementary to his primary interest or vocation."


b. 1.b.(6):

"b. The utilization of individuals by contract will be subject to the following restrictions:


"(6)....Similarly, Staff personnel will not be transferred to a Contract status except under extraordinary circumstances, and then only when approved by the Operating Official concerned."

c. 2.a. (Contract Employees):

"a.They will work under controlled and supervised conditions and be compensated on a salary basis. While not Staff Employees of the Agency they have an employee relationship to the United States Government and will receive rights, benefits and privileges in accordance with their citizenship status...."

4. The transfer proposed in Paragraph 2 above is feasible and advantageous. T/O and ceiling positions will be saved. More flexibility and latitude in control of work performance will be secured. Contribution to overhead saving will be obtained.  permits the shift-over. Pressure on Agency ceiling warrants this action.
