INSTRUCTION:

GROUP'S MORALE AND ENTHUSIASM ARE HIGH. INSTRUCTION THUS FAR HAS

WERE COMPLEMENTED BY AN [Redacted] STAFFER'S DESCRIPTION OF A RECENT
OPERATION WHERE THESE TECHNIQUES WERE CRITICAL. FINALLY, THE GROUP
RECEIVED TWO EXCELLENT OPERATIONAL STATUS REPORTS ON NONOFFICIAL
COVER AND OPERATIONS AGAINST THE [Redacted] TARGET.

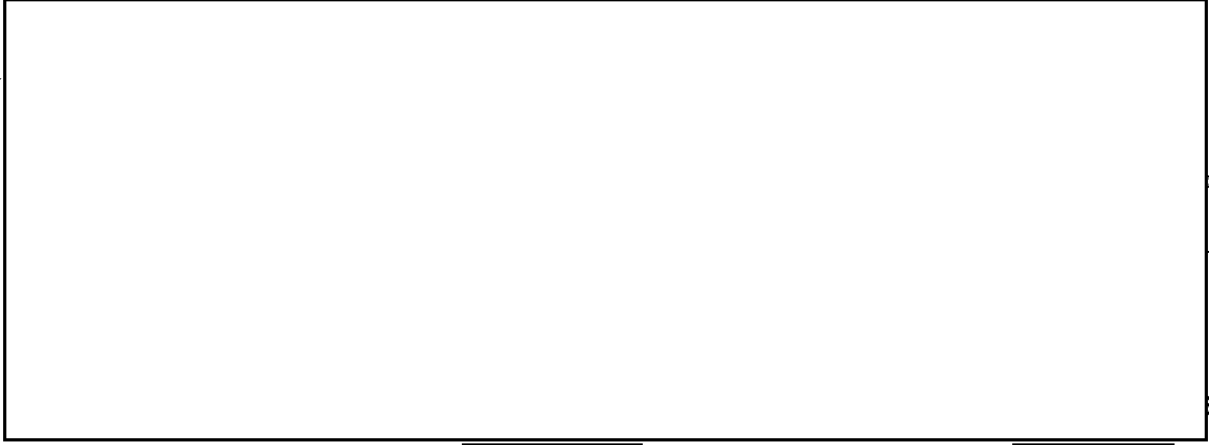

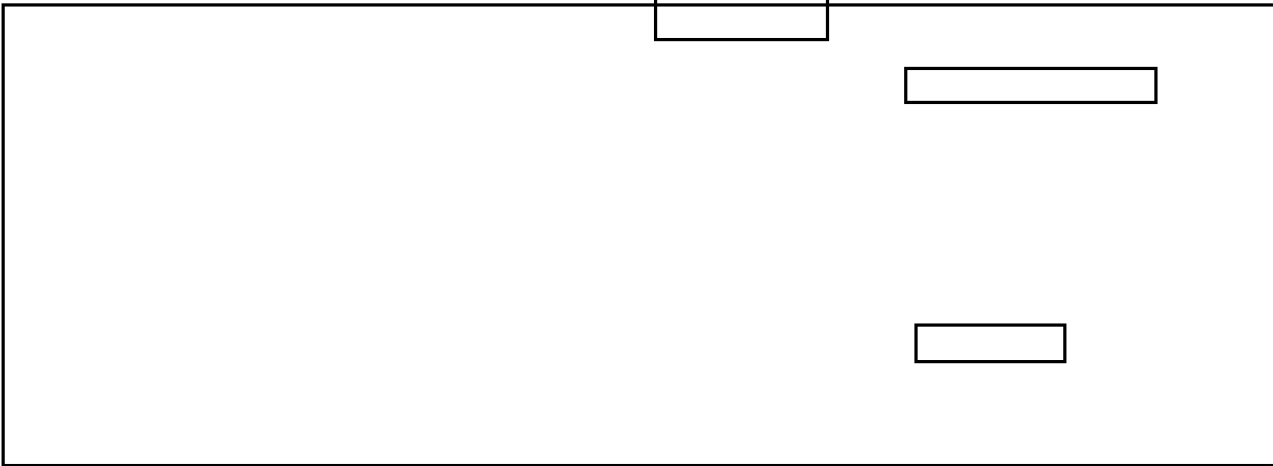
