Designating the Central Intelligence Agency,
Its Officers and Employees, as Excepted from
Certain Provisions of the Act to Authorize
the Training of Federal Employees at Public
or Private Facilities

By virtue of the authority vested in me for the conduct of foreign
affairs, by Section 4(b) of the Government Employees Training Act, P.L.
85-507 approved July 7, 1958 and as President of the United States, having
determined that exception of the Central Intelligence Agency, its officers
and employees from certain provisions of the Government Employees Training
Act is in the public interest, I hereby designate the Central Intelligence
Agency together with its officers and employees as excepted from the
following provisions of the Act:

- ✓ 1. Sec. 2(4), United States Civil Service Commission responsibility
or authority for training operations, their promotion or coordination
within the Central Intelligence Agency.
- ✓ 2. Sec. 5, "Departmental Reviews of Training Needs."
- ✓ 3. Sec. 6, "Training Regulations of Commission."
- 4. Sec. 7, "Establishment of Programs of Training Through Govern-
ment and Non-Government Facilities."
- 5. Sec. 8, "General Provisions of Programs of Training Through
Government Facilities."
- 6. Sec. 9(b), To provide for information to be made available to
employees with respect to the selection and assignment of employees
for training.

8. So much of Sec. 10 as would require payments made for expenses of training to be in accordance with regulations issued by the Commission.

9. Sec. 11, "Agreements of Employees Receiving Training Through Non-Government Facilities to Continue in Government Service for Certain Periods."

So much of Sec. 11(c) as provides for waiver of recovery, "in accordance with regulations of the Commission."

10. Sec. 12, "Limitations on Training of Employees Through Non-Government Facilities."

11. Sec. 14, "Prohibition on Training Through Facilities Advocating Overthrow of the Government by Force or Violence."

12. Sec. 15, "Review by Commission of Programs of Training Through Non-Government Facilities."

13. Sec. 16, "Collection of Training Information by Commission."

14. Sec. 18, "Reports."

15. So much of Sec. 19(c) as provides for reduction of payments "in accordance with regulations of the Director of the Bureau of the Budget."

16. Sec. 19(d), Qualification of training through any non-governmental facility which is conducting propaganda or influencing legislation, or is participating or intervening in political campaign on behalf of candidates for office.

17. Sec. 23(a), "Absorption of Costs Within Funds Available."
